INSTRUCTIONS FOR COMPLETING PROOF OF CLAIM

TO: POLICYHOLDERS AND OTHER POTENTIAL CREDITORS OF
GLOBAL HAWK PROPERTY & CASUALTY
INSURANCE COMPANY IN LIQUIDATION

Global Hawk Property & Casualty Insurance Company ("GHPCIC") has been ordered liquidated by the Court of Chancery of the State of Delaware in the matter now captioned as "In the Matter of the Liquidation of Global Hawk Property & Casualty Insurance Company, C.A. No. 2020-1044 (PAF)." The Court appointed The Honorable Trinidad Navarro, Insurance Commissioner of the State of Delaware, as the Receiver (the "Receiver") of GHPCIC. In the January 7, 2021 Liquidation and Injunction Order, the Court also ordered that the Bar Date for filing all claims against GHPCIC with the Receiver shall be **June 30, 2021**.

The proof of claim form must be completed in accordance with the instructions, must be signed under oath, and must be returned to the address indicated on the proof of claim form on or before the Bar Date of June 30, 2021, so that the proof of claim and supporting documentation are RECEIVED by the GHPCIC estate by that date, or your claim will be barred from sharing in any distributions of assets from the GHPCIC estate unless assets become available to pay Class VII (late-filed) claims.

YOUR SUPPORTING DOCUMENTATION MUST PROVIDE PROOF OF YOUR CLAIM AGAINST GHPCIC.

Any claimant who fails to file a proof of claim as required shall be forever barred from sharing in the assets of the GHPCIC estate unless assets become available for distribution to the Class VII (late-filed) claims.

Each section of the proof of claim should be completed. If a section is not applicable, please so state. A separate proof of claim form should be completed for each claim against GHPCIC. (If you believe you have more than one claim, you should photocopy the proof of claim form for the additional claims.) You may use photocopies of the Proof of Claim form, but the claimant's signature and the notarization submitted to the Receiver must be the original signature and notarization. All interested parties are encouraged to complete and send in their proof of claim forms as soon as possible. A fillable PDF version of the Proof of Claim form will be posted on the website listed below.

Assets are distributed in accordance with the priority classes established in the Delaware Insurance Code. No priority class will share in any distribution of assets unless and until all higher priority classes have been satisfied in full. The Liquidation and Injunction Order, the Order setting the Bar Date and providing for the cancellation of insurance policies and contracts of insurance, and other relevant documentation can be found on the web page for GHPCIC on the Delaware Insurance Department website at:
